1. Introduction of Trustees and Reliable Property Management

2. Overview of Financials

- a. Keith provided an analysis of the TTP current financial situation, and a summary of the maintenance and infrastructure projects completed in 2022. There were some issues with labor, rising costs, and unforeseen natural events (tree falls) which required some changes in plans. i.e. only 2 buildings were painted instead of the 3 that had been planned. Despite such setbacks, TTP was able to accomplish most of the projects planned and ended the year in a good financial position with only a very small deficit. TTP currently has over \$115K in its reserve fund and \$46K in the operating fund.
- b. Keith reviewed the new forecasting and schedule for Capital Improvements planned for the next several years.

3. 2023 Budget

- a. Keith shared the 2023 Budget, highlighting the major reoccurring expenses such as Landscaping (\$25K), Tree Service (\$10K), Snow removal (\$22K) as well as some of the smaller infrastructure and maintenance work planned and budgeted for he coming year.
- **b. Keith also reviewed the new condo fees** which will increase by 5% starting February 2023.

All Unit owners have received notification of the budget and CF by mail.

4. 2022 Accomplishments

Karthi reviewed the list of accomplishments over the past year. As usual - the TTP Board has worked very hard to maintain our beautiful property and plan for the future!
